We want to be sure our parents and guardians are knowledgeable about the assessments. The chart below will help you be informed about what content areas are assessed at each grade.

3	Math and Reading-Multiple Choice, Multiple Select, Technology Enhanced, and Short Answer
4	Math, Reading and Science- Multiple Choice, Multiple Select, Technology Enhanced, and Constructed Response
5	Math, Reading, Social Studies, On Demand Writing-Multiple choice, Multiple Select, Technology Enhanced, Constructed Response, and one Writing Prompt
6	Math and Reading-Multiple Choice and Selected Response
7	Math, Reading and Science-Multiple Choice, Multiple Select, Technology Enhanced, and Constructed Response
8	Math, Reading, Social Studies, On Demand Writing-Multiple Choice, Multiple Select, Technology Enhanced, Constructed Response, and one Writing Prompt
High School	
10	Math and Reading
11	College Readiness Exam (ACT), Science, Social Studies and On Demand Writing
12	Career Readiness Assessments (KOSSA, Industry Certifications, etc. ACT) as needed.
